Emergency Response Efforts – On the Front Lines Fighting Hunger March 20-July 31, 2020


When faced with the mandatory shutdown of our state and our schools due to the COVID-19 pandemic, America's Second Harvest immediately flipped the switch ON for emergency response efforts.

We have hosted 118 socially distanced, no contact Emergency Mobile Food Pantry Drive Through Distributions.

We have distributed 10,234,802 pounds of food, which represents the equivalent of 8,529,000 meals.

We have experienced a distribution increase of 49% over the same time period in 2019.

All of this was possible through the cooperation of our partner agencies in 21 counties, permission from Governor Brian Kemp to enlist the Georgia National Guard, and the help of community organizations, supporters, donors, and volunteers. We appreciate your time, assistance, and support to expeditiously distribute food to 300-1,400 cars at each location in just a few hours.

From the Executive Director

Dear Friends:

As I write this letter, I am reminded that when I started at Second Harvest in 2002, food insecurity in coastal Georgia was something that I wasn't aware even existed. Seeing the senior and child that didn't know where their next meal would come from, and seeing the crying parent that couldn't feed their family, made me realize we sometimes don't know what people are going through.

Thankful, Grateful, Blessed

Thankful to have been awarded \$500,799 of the Jeff Bezos COVID-19 \$100 million Relief Grant. This grant was offered for immediate support of the 200-member food banks of the Feeding America network. During crisis response, our food bank has incurred a huge burden of expenses in order to source additional food, supplies, transportation and increased operations. Unemployment numbers continue to skyrocket across our communities and we are faced with the reality that this response will go on for months and the economic impact could go on for years. Many families are turning to food banks for the first time, and we have seen a dramatic increase in the number of people who suddenly need help due to businesses being shut down, employees being laid off or let go, and mandated school closures.


Grateful for the support of over 500 donors within the month of May that contributed to the May Match Challenge of \$150,000 awarded by an anonymous donor. Since the nationwide shutdown in March, we have seen some creative and resourceful means of fundraising. A few that stand out to us are:

- WTOC's benefit concert and telethon for local food banks
- Individuals donating their government stimulus checks
- WJCL's Thursday promotions of our Grab & Go meals for the children
- The Fabulous Equinox Orchestra's free online concert with virtual ticket sales and sponsorships
- Welland Racing/NEXGEN Junior Development Cycling team's donation of funds they raised for their season that didn't happen
- Zunzi's Families Feeding Families Initiative that matched meal to meal for those struggling with hunger

Blessed to have compassionate donors, corporate sponsors and partner agencies both locally and nationally that make it possible for us to feed the need in Coastal Georgia. The support we have received during this unprecedented and incredibly stressful time has allowed us to maintain operations and purchase food and supplies in greater quantities than ever before. The need for food has been immediate in the midst of the sudden flare-up and panic brought on by the COVID-19 health crisis.

Since the outbreak of COVID-19 and the mandated school closures, our primary concern has been to continue to feed the children. To date, Grace's Kitchen has prepared 468.345 Grab & Go meals and with the assistance of the Georgia National Guard and our Kids Cafe partners the meals have been distributed as Drive Thru, stay in your car, take away service. Normally during the school year, we provide evening Kids Cafe meals five days a week. When struck with COVID-19 and school closures, we switched over to Grab & Go breakfast and lunch. Grab & Go meals have continued throughout the summer since camps and group programs have not been allowed. Meals are packaged in To Go containers and then hot boxes for delivery with our kitchen staff starting their days at 4am in order for six delivery trucks to be on the road by 6am.

This truck will be used to pick up grocery donations, make agency deliveries, and shuttle food to our Mobile Food Pantry distributions in the Golden Isles and surrounding communities.







Golden Isles YMCA employees Tiffany Randolph, AJ Kirkland, and Carly Lawson helped to distribute 300 Grab & Go meals weekly to area kids that were impacted by school closures. They also gave out hundreds of boxes of fresh fruit and vegetables from the USDA Farmers to Families Food Box Program made possible through the CARES Act 2020. We appreciate the partnership of the Golden Isles YMCA and for helping us reach those in need of food during these challenging times.

The College of Coastal Georgia has made their campus available to host drive-through emergency food distributions and feed the need in Glynn county during the pandemic.
